Evolution of Interconnecting Refrigerant lines on Split Systems

As equipment evolves and refrigerants change, the practices employed to install interconnecting refrigerant piping should also evolve. Efficiency and reliability rely heavily upon the methods used to interconnect the condensing unit with an air handler.

Old practices are not necessarily correct for a system to function properly and in most cases these practices actually hinder overall system performance.

Some of the techniques discussed below would have been considered "bad engineering" in the past, but currently work effectively with today's modern scroll compressors and R-22 refrigerants. A successful application is based on proper selection of equipment and properly designed interconnecting piping.

When selecting equipment the following information should be used as a guide:

- Selection of coil should be based on a minimum suction temperature of 40 degrees Fahrenheit for VAV systems. This will essentially promote stable performance over the systems entire operating range.
- Hot-gas bypass should be avoided in comfort cooling applications. It is seldom needed in properly designed systems and often wastes energy. If a designer is concerned about coil frosting, the use of evaporator defrost control should be considered.

In order to maximize system efficiency and reliability, consider the following general guidelines when laying out interconnecting piping:

- Limit the overall line length of piping. Whether the piping is horizontal or vertical, suction or liquid, it is important to minimize piping runs to avoid added pressure drop and problems with the refrigerant. Both will reduce compressor efficiency and capacity.
- Always use Type L copper tubing for R-22 applications.
- Whenever possible, utilize the manufacturer's software to ensure proper suction and liquid line sizing for your application. Piping distances, both vertical and horizontal, can be evaluated to ensure the piping is properly designed.
- Pitch the liquid and suction line one inch toward the evaporator for every ten feet of run.
- Always use and properly maintain filter dryers. It is extremely important to keep the refrigerant clean.

Pressure drop in the suction line adversely affect unit capacity and efficiency. High-pressure drops can reduce compressor capacity and efficiency. Accordingly, when considering suction line sizing, it is important to follow the following criteria:

- Different pipe sizes should be used for horizontal and vertical lines.
 This makes it easier to match line pressure drops and refrigerant velocity to suction line requirements.
- In order to ensure proper oil entrainment and avoid sound transmission, size the suction line so that the refrigerant velocity equals or exceeds the required minimum velocity as determined by the equipment manufacturer.
- Riser traps are not needed if the riser is properly sized to maintain velocity. The use of traps only increases the suction line pressure drop.

Insulate the suction line if condensation and dripping pose a problem, or to prevent refrigerant from condensing inside the line if the piping is exposed to low temperatures.

In order for equipment to function properly, sufficient sub-cooling must be maintained at the expansion valve. To provide proper operation throughout the range of operating conditions, the liquid line pressure drop should not exceed the unit's minimum sub-cooling value less 5 degrees Fahrenheit. General guidelines for refrigerant piping are listed below:

- The smallest practical line size for the application should be used. Limiting the refrigerant charge improves compressor reliability.
- When designing the liquid line, remember that every ten feet of vertical rise will reduce sub-cooling by 2.8 degrees Fahrenheit, and every ten feet of vertical drop will add 1.1 degrees Fahrenheit of sub-cooling.
- Solenoid valves are required to prevent liquid refrigerant from filling the evaporator when the compressor stops and slugging when the compressor restarts.
- If the liquid line is routed in an area warmer than the outdoor air temperature, the line must be insulated to prevent the refrigerant from flashing.
- Use a moisture-indicating site glass to visually check the liquid column for bubbles.

It is imperative to follow proper procedures when specifying, designing, and installing a split air-conditioning system. Without such procedures, the reliability, efficiency, and capacity will be compromised.
