Scientists debate both the severity and rate of global warming, while extremists challenge whether it is occurring or whether it points to catastrophic impacts that already have started. Is global warming real? Yes, and the presentation will show why and what it means. Is air conditioning one of the causes or should we just put in more of it to adapt to warmer temperatures? Yes, it is a cause and in more ways than one. And yes, we will need more of it in some places. Climate change affects far more than temperature, so we will have to do a number of things differently. Global warming did not cause the recent tsunami, but its long-term consequences could be much more severe. | | | | | |
| About our Speaker: | James M. Calm, P.E. is an internationally-recognized engineering consultant specializing in heating, air-conditioning, and refrigerating systems. Much of his work involves the application and safety of alternative refrigerants. New York Institute of Technology (NYIT)

NYIT is one of 18 colleges internationally - and the only university in the metropolitan area - selected as a finalist in the global 2005 Solar Decathlon Competition, sponsored by the U.S. Department of Energy. We believe that humans can live in harmony with the Earth as part of one sustainable environment. Green Machine/ Blue Space will demonstrate the regenerative power of our commonwealth: sun, earth and living things. Our design separates the mechanics of life from leisure space to create a house of two parts which can be adapted anywhere.

NYIT's entry into the Solar Decathlon is entitled "Green Machine/Blue Space". In the Green Machine, the mechanics (power-users, heat-producers) of the house are removed from the living spaces to collectively form the beating heart of the entire house. This creates a warmer, denser box that houses the processes of life: A roof garden to grow food that we eat, the kitchen to wash and prepare food, a bathroom for the waste we produce and a non-polluting hydrogen fuel cell that produces the cleanest form of energy.

The Blue Space is left unencumbered by appliances and other mechanics. The space is open and adjustable for the inhabitants. There is a loft for sleeping or reading with plenty of light from clerestory windows. When up in the loft, one can look out onto the backyard or the roof garden of Green Machine. A bridge connects the loft to the garden.

The NYIT team realizes the need for a global design approach. Green Machine is universal and self sufficient as long as it's connected to a Blue Space with photovoltaics. The Blue Space can therefore be indigenous to its locale.

Visitors at the NYIT Solar house will be educated by rich media animations via a Pocket PC (with integrated barcode scanner) that describes visually the technology used throughout the house. Barcodes are located strategically throughout the house on technologies that might be of interest to our visitors. The PCs serve up a wealth of information when scanned. 
We are having a good year with new member recruitment. A special thanks to our members who have recruited their co-workers. I appreciate all of your efforts.
