

# History

It is my pleasure to welcome you back to another great year with our Long Island chapter. ASHRAE Region 1 CRC was held in Portland, Maine this summer where we all partook in a little history.

As your new chapter historian I attended the workshops, which made me realize what an important role it is to not only share our chapter history, but maintain our archives. As time goes on, the archives pass through the many hands of people who have or will contribute to our history. Those very hands are without intention the same ones that deteriorate the paper on which it's held. There is an incredible amount of information that needs to be preserved. Just because we're talking history doesn't mean we can't take a step into the future. My goal this term is to digitize chapter archives.

Speaking of the future..... Answer this to get some insight on next dinner presentation:

In air conditioning, it is exploited to increase the throw of a ceiling mounted diffuser. It causes air discharged from the diffuser to "stick" to the ceiling. It makes the discharge air travel further before dropping for the same discharge velocity than it would if the diffuser was mounted in free air, without a ceiling. In variable air volume systems it permits greater turn down ratios.

This principle is the \_\_\_\_\_\_ discovered in 1930 by Romanian inventor \_\_\_\_\_\_\_. Although the discovery was originally made during aircraft development experiments it is fundamental in air distribution today.
